



## **LINEAR & PRODUCT WARRANTY CERTIFICATE**

Sonali Solar guarantees for 25 years performance from the date of shipment that our Solar PV modules are free from all defects in material and workmanship on 60 and 72 cell series Modules. Any modules with such defect shall be replaced free of charge within the warranty period for the first 12 years on product warranty.

Sonali Solar further guarantees the rated power\* output of its modules for a period of 25 years from the date of shipment. This guarantee affirms that the output will be at least rated 90% of the rated power output during the first 10 years and 80% of the rated power output in the next 15 years. Sonali Solar will have the option to repair or replace the module to bring the aggregate power output to the warranted percentage of specified rated power output in case of deficiency.

\*Rated power output is determined as a standard under the test conditions of cell temperature of 25 degrees Celsius and Irradiance of 1000W per sq meter and AM -1.5 spectrum.

Replaced modules will become the property of Sonali Solar.
2. Sonali Solar is not responsible for any special, incidental, consequential or punitive damages arising from the use or loss due to use of or failure of the Sonali Solar product to perform as warranted, including but not limited to damages for lost services, cost of substitute services, lost profits or savings, expenses arising out of third-party claims and personal injury. Sonali Solar's maximum liability under any warranty, expressed, implied, statutory, or for any manufacturing or design defect, is limited to the purchase price of the product. The purchaser's remedy for breach or for manufacturing or design defects shall be only as stated herein.

#### **WARRANTY CLAIM PROCEDURE:**

Claims under this warranty shall be considered if the customer, within 30 days following the discovery of any defect covered under this warranty, sends back the modules to the address of the factory of Sonali Solar. Sonali Solar will then examine and analyze the material or workmanship claimed to be defective. If the claim is validated Sonali Solar will repair or replace the defective modules. The customer shall be responsible for the cost of shipment of the repaired and/or replacement modules to and from the factory.

#### **FORCE MAJEURE:**

This guarantee shall not, however, extend to normal wear and tear, replacement or repairs necessitated by the reason of willful damage, careless handling, acts of God, natural calamity and other circumstances beyond Sonali Solar's reasonable control. In the event of any dispute in this regard, the opinion of an independent institute regarding the cause of any damage will prevail.
